## **Industry Update**

As your President and CEO, I strive to provide not only our patron members, but our livestock marketing industry with highly effective leadership, even in the midst of industry disruptions, staffing challenges, and the ongoing legislative and regulatory uncertainty. The executive team and regional board work together to anticipate and plan for such matters and turn them into opportunities, but sometimes other challenges will catch us off guard.

Your executive team and regional directors believe it is important to the cooperative, its employees, and patron members for us to develop and maintain industry relationships and be active in industry organizations. These provide the opportunities for us to be an influential voice in advocating for policies and staying informed on topics that impact our industry at the national, state, and local levels.

For the past year and a half, we have been advocating for a new Farm Bill and improvements to our immigration programs. We have seen little movement in Congress with either of these topics, but the Administration has been very busy issuing new regulations and rules that affect your cooperative. Here is a list of the major changes we are working to comply with:

#### USDA Federal Order Requiring Mandatory Bovine Influenza A Virus (BIAV) Testing for Interstate Movement of Dairy Cattle – April 24, 2024

April 24, 2024, the United States Department of Agriculture announced a new Federal Order requiring certain measures to be implemented, effective April 29, 2024. These measures are to further protect the United States livestock industry from the threat posed by the highly pathogenic H5N1 avian influenza. These new measures include the following:

1. Mandatory Testing for Interstate Movement of Dairy Cattle

a. Lactating dairy cows moving interstate must adhere to conditions specified by APHIS, including a negative test for Influenza A and a certificate of Veterinary Inspection (CVI).

b. Owners of herds with positive tests will be required to provide epidemiological information, including animal movement tracing.

c. These steps are immediately required for lactating dairy cattle, these requirements may be implemented for other classes of cattle as scientific factors evolve.

2. Mandatory Reporting

a. Laboratories and state veterinarians must report positive Influenza A nucleic acid detection diagnostic results in livestock to USDA APHIS. b. Laboratories and state veterinarians must report positive Influenza A serology diagnostic results in livestock to USDA APHIS.

USDA APHIS has an exception for cattle moving interstate if their only destination after crossing the state boundary is a slaughter facility. In this situation, lactating diary cows can be moved on an owner/shipper statement without a test or CVI, only if both the originating state and receiving state allow for this type of form to be used. Lactating dairy cows can move freely within their home state, but if they are leaving their home state to go anywhere except directly to a slaughter facility, they need a negative Influenza A test and a CVI.

#### USDA APHIS Releases Final Animal Disease Traceability Rule, April 26,2024

On May 9th, the United States Department of Agriculture (USDA) Animal and Plant Health Inspection Service (APHIS) printed a final rule to amend and strengthen its animal disease traceability regulations for certain cattle and bison. These changes will be effective 180 days from that date.

The primary change is all official identification tags applied after November 5, 2024, will be required to be both, visually and electronically readable. USDA is not changing the type of animals requiring to be tagged, cattle and bison that move interstate and are sexually intact and 18 months of age and over, all dairy cattle, cattle and bison of any age used for shows, exhibitions, rodeos, or other recreational events must all continue to have official identification. USDA has said they

will allow animals with current non-electronically readable tags to continue to use those tags for the life of the animal, however, any animal being tagged after November 5th will be required to use the updated visually and electronically readable tag.

In addition to updating the definition of "Official Eartag," other definition changes include "Approved Tagging Sites," "Interstate Certificates of Veterinary Inspections," and "Dairy Cattle." This change in the definition of "Dairy Cattle" is outlined here:

*Prior definition:* "All cattle, regardless of age or sex or current use, that are of a breed(s) used to produce milk or other dairy products for human consumption, including, but not limited to, Ayrshire, Brown Swiss, Holstein, Jersey, Guernsey, Milking Shorthorn, and Red and Whites."

*New definition:* "All cattle, regardless of age or sex or current use, that are of a breed(s) or offspring of a breed used to produce milk or other dairy products for human consumption, including, but not limited to, Ayrshire, Brown Swiss, Holstein, Jersey, Guernsey, Milking Shorthorn, and Red and Whites."

**Result:** USDA states in the rule this definition change is intended to capture those beef and crossbred calves born to a dairy cow and require those calves to be tagged under the dairy cattle definition.

The new rules refer to a database and data security for these electronically readable official identification tags but we are waiting on more guidance to fully understand what that is and the details associated with it.

## USDA Inclusive Competition and Market Integrity Under the Packers and Stockyards Act

The Agricultural Marketing Service ("AMS") Packers and Stockyard Division of the United States Department of Agriculture's Inclusive Competition and Market Integrity Rule, Subpart O ("Rule") goes into effect on May 6, 2024.

In summary, as provided by 9 Code of Federal Regulations 201, the Packers and Stockyards Act and the Rule are intended to "prohibit undue prejudice and unjust discrimination against individuals on a prohibited basis unrelated to the quality of the service or product provided. The [R]ule also identifies retaliatory practices that interfere with lawful communications, assertion of rights, and associated participation, among other protected activities, as unjust discrimination prohibited by the law. Finally, the [R]ule identifies deceptive practices that violate the Packers and Stockyards Act with respect to contract formation, contract



performance, contract termination, and contract refusal. The purpose of the [R]ule is to promote inclusive competition and market integrity in the livestock, meats, poultry, and live poultry markets."

#### USDA final rule on voluntary "Product of USA Label" – March 11, 2024

USDA's Food Safety Inspection Service (FSIS) announced and printed final changes to rules for the voluntary "Product of USA" label. These changes basically closed the loopholes allowing imported meat to be processed and/or packaged in the USA to bear this label. The new rule requires that a product be from an animal that was born and raised in the United States in order to bear this label.

#### United States Department of Labor Updates Several Rules Requiring Employer Action

At the federal level, the Department of Labor (DOL) has been very busy with their Occupational Safety and Health Administration (OSHA) issuing a couple of new rules on workplace inspections and hazardous communications. DOL's Wage and Hour Division (WHD) issued some changes to employee wage requirements and the Employee Benefits Security Administration (EBSA) also finalized some retirement plan rule changes.

The executive team and regional board directors recognize the mutual accountability and shared purpose to not only ensure the cooperative continues to operate within the parameters set by our regulatory agencies, but to ensure Equity remains a strong voice for our producer members. Representing our members, and the cooperative as a whole, allows for optimal value and the ability to unlock what is possible within the cooperative.

# **Paying Tribute to Lynn Merow**

Lynn was involved with Equity for over half his life. Born in Sparta, Lynn operated a 980-acre farm with his two sons. His family had roots in the area since his

great-grandparents started farming in the 1850s.

Lynn Merow began on Equity's Regional Board in 1957 and finished his term in 1998, missing only two meetings in that 41-year span. He served as Board Chairman from 1981-1995. Lynn passed on his desire to contribute to agriculture by

## High in the Future

Earlier this spring, live cattle futures experienced a short scare in prices. Although cattle futures are not back to contract highs, futures have strongly retraced back to higher money. This uptick in prices continues to be fed with the lack of cattle inventory and high consumer demand in the marketplace. Higher cattle prices have attracted additional buyers, maintaining steady to higher markets. However, due to higher prices, financial risk exposure for producers has increased significantly.
